Japan Society of Powder and Powder Metallurgy (JSPM)

Guidelines for Submissions to "Journal of the Society of Powder and Powder Metallurgy"

(Revised: January, 2023)

1. Aims and Scope

These guidelines relate to the submission of paper, rapid communication, short note, technical report, memorial lecture of JSPM Award, general review, and review for publication in "J. Jpn. Soc. Powder and Powder Metallurgy".

2. Types of Papers

Submitted paper, rapid communication, short note, technical report, memorial lecture of JSPM Award, general review, and review must contribute to JSPM and to the relevant fields.

2.1 Paper

A summary of the results of research, development, and study on fields relevant to JSPM, with high novelty and reliability

2.2 Rapid Communication

A communication regarding important research findings that needs to be published immediately, even if the research is still in progress

2.3 Short Note

A note regarding findings that are worth publishing, but are supported by less research data than a "paper"

2.4 Technical Report

A summary of data obtained through experiments and/or tests, which should serve as useful and important technical data

2.5 Technical Rapid Communication

A communication regarding new manufacturing technologies, newly developed products, developments and improvements in measuring techniques

2.6 New Techniques and New Products

A summary regarding of original new technologies, newly developed products, developments in measuring techniques and/or product improvements which have been put into practical use.

2.7 Memorial Lecture of JSPM Award

A summary of research achievements upon which a JSPM Award has been bestowed

2.8 Review (General Review)

A general commentary on a particular subject, which is based on a reference and technical data

2.9 Review

A clear description of a particular subject that has already been published

3. Copyright

- 3.1 The copyrights of paper, rapid communication, short note, technical report, memorial lecture of JSPM Award, general review, and review published in "J. Jpn. Soc. Powder and Powder Metallurgy" belong to JSPM.
- 3.2 The accepted articles are published under the Creative Commons Attribution-Non Commercial-No Derivatives 4.0 International (CC BY-NC-ND 4.0) (Attribution-Non Commercial-No Derivatives) License (CC License). The authors must agree to be granted the CC license.

4. Membership for Submission

The contributor to "J. Jpn. Soc. Powder and Powder Metallurgy" does not necessarily need to be a member of JSPM.

5. Corresponding Author

The corresponding author shall be a person capable of carrying out the following responsibilities.

- 5.1 The corresponding author will be responsible for everything from submission to publication (submission, peer review, proofreading, payment of publication fees, etc.) with the JSPM secretariat.
- 5.2 The corresponding author shall enter his/her e-mail address in the footnotes of the manuscript.
- 5.3 As a general rule, only one corresponding author can be accommodated in a manuscript. In addition, with the consent of all authors, the corresponding author can be substituted by another author of the manuscript. However, this is limited to cases in which the editorial committee has accepted the offer submitted with the reason.

6. Multiple, redundant or concurrent publication

Submitted paper, rapid communication, short note, and technical report are limited to those have not been previously published in any other publications prior to the Journal of JSPM and have not been currently submitted to any other publications.

7. Manuscript receipt date

The reception date of a submitted manuscript shall be the date in which the manuscript has been submitted to our online manuscript submission and review system. Note that a manuscript that violates these submission guidelines and is not compliant with "The Instructions of J. Jpn. Soc. Powder and Powder Metallurgy" (specified separately) may not be accepted.

8. Peer Review

The decision as to whether or not a submitted manuscript will be published is made following a peer review by the Editorial committee.

9. Withdrawal of Manuscript

A submitted manuscript for which corrections were requested by the Editorial committee and for which a corrected version is not submitted one month from the date the manuscript is returned will be regarded as withdrawn.

- 10. Manuscript and Submissions
 - 10.1 A submitted manuscript shall be prepared in English.
- 10.2 Submissions should be made via the online manuscript submission and review system Editorial Manager.
- 11. Publication Fee
- 11.1 The contributor shall pay a publication fee (specified separately). If you wish to have a figure(s) printed in color, you shall pay for the actual cost incurred.
- 11.2 Errata owing to author's mistake can be published after publication of the article. Author will bear the actual cost of the correction. In case of the serious correction related to understanding of the contents, the decision as to whether or not the correction will be published is made by the Editorial committee.
- 11.3 As desired, the contributor of an article can request a PDF file and the reprints of the article at cost.
- 12. Resubmission to the Collaborative Publication of the English Journal "Materials Transactions"
- 12.1 A paper (in Japanese) published in "J. Jpn. Soc. Powder and Powder Metallurgy" can also be submitted in its English version to "Materials Transactions" within one year of the date of publication. It is not possible to change the author(s) and the content of the paper. It should be stated as a footnote that the article has already been published in Japanese as follows:

"This paper was originally published in Japanese in J. Jpn. Soc. Powder Powder Metallurgy, **volume number** (publication year), starting page number - ending page number." And if there is a difference with the original paper in Japanese, it should be stated as a footnote.

12.2 The category types that can be submitted to "Materials Transactions" include "Papers", "General Review" and "Review". Under the categories specified in "Materials Transactions," these category types correspond to "Regular Articles", "Review" and "Overview", respectively.

Guidelines for Submission of New Technologies and New Products

(Revised July, 2019)

- 1. These guidelines relate to submission of new technologies and new products for publication in "J. Jpn. Soc. Powder and Powder Metallurgy."
- 2. The submission must relate to original new technologies, newly developed products, developments in measuring techniques, or product improvements in the fields related to powder and powder metallurgy, which have been put into practical use.
- 3. A contributor shall be a corporation member or own a regular membership at the time in

- which he/she may be awarded, and the authors must consist of less than five persons.
- 4. The submitted article is required to include the following information (including technologies and photographs of products):
 - ① Background and purpose of the development
 - 2 Technical achievements and features
 - ③ Intended use, range of application, actual production, etc.
 - 4 Future developments
 - ⑤ Patent(s) (each accompanied with a publication number, a patent number, etc.)
- 5. The authors of "new technologies and new products" published in "Journal of Japan Society of Powder and Powder Metallurgy" can be candidates of the award of "new technologies and new products" of Japan Society of Powder and Powder Metallurgy.
- 6. Submissions shall apply to the "The Instructions of J. Jpn. Soc. Powder and Powder Metallurgy", with the exception that an abstract (in English along with its Japanese translation) is not required.
- 7. Publications shall be of 3 or less printed pages, and the contributor of the publication shall pay a publication fee specified below (you can request 100 reprints or a PDF file). Note that a publication fee for corporation members varies as follows, depending on the number of units:

Member other than corporation member		¥150,000(+Tax)
Corporation member	1 unit	¥120,000(+Tax)
	From 2 to 4 units	¥100,000(+Tax)
	5 or more units	\$80,000(+Tax)

8. Other regulations apply to "The Guidelines for submission to J. Jpn. Soc. Powder and Powder Metallurgy".

Japan Society of Powder and Powder Metallurgy (JSPM) Instructions of "J. Jpn. Soc. Powder Powder Metallurgy"

(Revised January 2023)

1 Introduction

A submitted manuscript shall be prepared in English. In principle, the number of printed pages for a manuscript for "new technologies and new products" should be 3 or less pages and that for a "technical rapid communication" should be 4 or less pages. Otherwise, there is no limitation on the number of printed pages for a manuscript.

We have introduced an online manuscript submission and review system called Editorial Manager[®]. When making a submission, you are requested to first log-in to the Editorial Manager[®] website (https://www.editorialmanager.com/jjspm/) and register yourself as a user. Upon review of the author's manual, please have files ready for the manuscript, the figure(s), the table(s) and the photo(s) (please refer to Manuscript Samples; the manuscript and the figure(s) should be stored in separate files) and a copyright transfer agreement (downloaded from the homepage). After inputting your user name and password, you may begin a new submission by clicking "Author Log-in."

2 Manuscript for Submission

The following instructions should be followed to prepare a manuscript for submission.

- ① Use A4-sized paper sheets (in portrait orientation) and leave a margin of 20 mm at the top, bottom, and sides of each page.
- ② Use a font size of 12 points and set the number of letters per line to 80 and the number of lines per page to 40.
- ③ Use the Times New Roman font, and the Symbol font for Greek letters.
- ④ Format using single spacing for all lines, except before headlines, in which case, please use double space.

2.1 Estimated Number of Printed Pages

Once the decision is made to publish a manuscript, the JSPM Office produces a final copy of the manuscript formatted for publication and printing. In this case, if the manuscript submitted consists of approximately 8 pages, the manuscript will be printed into 5 pages.

2.2 Title (Required Field)

Please refer to the Manuscript Samples and write the title, the author's name, and the name and address of the organization to which the author belongs in the order below.

① Submission Categories

A submitted manuscript should belong to one of the following categories: paper, rapid communication, short note, technical report, memorial lecture of JSPM Award, general review, review, technical rapid communication, summarization, new

technologies and new products, and Materials Transactions.

② Title

A title should be specific and describe the submitted contents. The title (including a subtitle) should be comprised of 120 or less letters. For the title, the first letter of each word should be in uppercase, with the exceptions of articles, prepositions, conjunctions, and relative pronouns.

③ Author's Name

Please write the author's name in full in the order of the given name and the family name, with the first letter of the given name and all letters of the family name appearing in uppercase. Please insert "and" before the name of the author listed last. Please add an asterisk mark in superscript "*" to the corresponding author.

- 4 Name and Address of the Organization
 - Please refer to the Manuscript Samples and reduce their length as much as possible to the extent that they are still legible for mail delivery. (The names of prefectures, except for "districts," should be omitted.)
- ⑤ Corresponding author's e-mail address
 Please use double spacing after the name and address of organization and write corresponding author's e-mail address as follows.
 - *Corresponding author, E-mail: <write your e-mail address>

2.3 Abstract and Key Words (Required Field)

An abstract should be comprised of 200 or less words. Please select 5 or less key words and list them after the abstract. As shown in the Manuscript Samples, they should have the headlines "ABSTRACT" and "KEY WORDS," respectively, with all letters appearing in bold uppercase. As for the key words, letters other than proper nouns should be in lowercase.

2.4 Body of Manuscript

When preparing a manuscript, please be concise and to the point, and avoid duplicate descriptions as much as possible.

Please use double spacing before each headline. For all other lines, please use a single space format.

2.4.1 Headlines

Please use double spacing before each headline. For a headline number, a number should be formatted in bold type and followed by one space without a period.

2.4.2 Subhead

Please use single spacing before each subhead. A subhead number should be assigned in sequence from a leading line, such as "1.1," "1.2," etc. One space should be inserted between the number and the subhead. After the space, letters should be used in non-bold

type.

2.4.3 Footnote

A footnote should be marked with symbols *1), *2), etc. and typed out at the bottom of a page, with a horizontal line drawn above the footnote.

2.4.4 Figures and Captions

- (a) Figures should not be inserted into the body of a manuscript, but submitted in a file separate from the manuscript body file. Please be sure to name the files and sequentially number figures and photos as Fig. 1, Fig. 2, etc. and tables as Table 1, Table 2, etc., when uploading the figure(s) etc.
- (b) Captions should be inserted altogether after "References," with double spacing used before the captions. After each figure caption, please indicate in parentheses whether the figure should be presented within one column of the double-column format or extended over both the columns of the double-column format to recognize the sizes of the figures and tables. (See the Manuscript Samples.)
- (c) In the event that one figure includes 2 or more figures or photos, please indicate (a), (b), (c) in their upper left sides, respectively. (See the Manuscript Samples.)
- (d) In figures and captions, only the initial letter of a first word should appear in uppercase, and other letters should be formatted in lowercase. As for the font type, Times New Roman should be used.
- (e) Letters in figures should be typed in a font size of 9 points or larger in consideration of balance of the letter when was printed.
- (f) In the case of a figure that is originally in color, please paste it as it is in color without changing it to gray scale. In principle, a figure, even if it is originally in color, will be printed in black and white.
- (g) If you wish to have a figure(s) printed in color, please ensure that this is stated clearly. The contributor shall pay the actual cost incurred for color printing.
- (h) Figure formatting will be completed by the JSPM Office.

2.4.6 Reprint

When reprint a text, a figure, a photo, a table, etc. from any other copyrighted work, it is your responsibility to disclose its source and obtain permission from the copyright holder to use it.

2.4.7 References

- (a) When citing references, please sequentially number the references and indicate the reference numbers in a right parenthesis in superscript form as follows: ¹⁻⁴), etc. for sequential reference numbers, and ^{1,5}), etc. for non-sequential reference numbers.
- (b) All references should be inserted at the end of the body of a manuscript.

- (c) In case of multiple authors, although it is desirable to list the names of all authors, when the number of authors exceeds two, it is permissible to use "et al." The names of those other than the author listed first can thus be omitted. The names of foreign journals can be expressed using abbreviations that comply with the international practices, SIST 05, ISO, etc.
- (d) The title of the Journal of JSPM should be written as "J. Jpn. Soc. Powder Powder Metallurgy," and the abstracts of annual meetings should be written as "Abstracts of Spring/Autumn Meeting JSPM, publication year (Christian era year)"
- (e) References should be specified as in the following examples:
 - Journals Author's name(s): Title of journal, **Volume number** (Publication year), Starting page number Ending page number.
 - Books Author's Name(s): Title of book, Edition statement, Publisher (Publication year), Pages.
 - Proceedings Author's name(s): Title of proceedings, Name of editor, Meeting venue, Meeting year, Name of organizer, Publisher (Publication year), Starting page number Ending page number.

2.4.8 Units and Symbols

- (a) Please use the SI units.
- (b) In principle, one space should be inserted between a numerical value and a unit.
- (c) Symbols used in thermodynamics, physical chemistry, nuclear physics, etc. and their rules of usage should comply as much as possible with the standards of the International Organization for Standardization (ISO) and the International Union of Pure and Applied Chemistry (IUPAC).

2.4.9 Numerals and Numerical Expressions

- (a) In principle, a numerical range should be typed out in the following manner: $(1.0\sim1.5)\cdot10^5$, $10\sim15$ s, etc.
- (b) As for numerical expressions in sentences, care should be taken to ensure that the numerical expression is typed out in one line, provided this does not cause a misunderstanding.

- (c) Please do not insert a comma and a period in a numerical expression unless necessary.
- (d) An exponential function should be enclosed within exp().

Topography of Ni element by EPMA analysis has confirmed that compacts with fine Ni powder demonstrates excellent Ni diffusion into the surrounding matrix as shown in Fig. 3 (a). 5 Summary

The effect of Ni distributions to the matrix has been studied for obtaining the excellent mechanical properties of injection molded Fe-Ni alloy steels using mixed elemental powders. Tempered Fe-6mass%Ni compact with fine mixed elemental powders achieved superhigh ultimate strength of 2040 MPa, yield strength of 1200 MPa, hardness of 56 HRC, and elongation of 8.1 %. EPMA analysis for Ni distribution confirmed fine and heterogeneous microstructure showed better performance in their mechanical properties. 
